Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of the Wonder Photography and may be used for advertising, display, publication or other purposes.

On return of this agreement within 14 days of contract date, Wonder Photography will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.

If Photographer cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then Wonder Photography will return all fees to the Client but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. The Client limits Wonder Photography's liability to the amount paid under this contract.

No part of any order will be delivered until Client's balance is paid in full.
